What is World Heritage?

World Heritage is the designation for places on Earth that are of outstanding universal value to humanity and as such, have been inscribed on the World Heritage List to be protected for future generations to appreciate and enjoy. UNESCO World Heritage Convention

1199 listed properties

48 Transboundary

168 Countries out of 195 countries have properties inscribed

About 2/3 are Cultural -1/3 Natural

Australia 20 properties –16 Natural 4 Cultural including Victoria's two properties

World Heritage Recognition of the Victorian Goldfields - APPROACH

 Need to demonstrate that the Victorian Goldfields are the world's most authentic and intact representative goldfields, and we have suitable management frameworks in place

Draft Statement of Outstanding Universal Value (OUV), -the Victorian Goldfields 'comprises a series of landscapes, rural and urban, that exemplify the goldrush phenomenon in all its technological, social and environmental character and consequences. Moreover, it represents one of the most significant and sensational goldrushes the world has ever witnessed.The principal global goldrush era is characterised by a succession of overlapping rushes from 1849 to 1900.'

Proposed criteria:

(iv)be an outstanding example of a type of building, architectural or technological ensemble or landscape which illustrates (a) significant stage(s) in human history (vi)be directly or tangibly associated with events...of outstanding universal significance.

We are now full partners with the Victorian Government, and we are working with Heritage Victoria to achieve World Heritage Listing

Partnership Vision

Secure World Heritage listing to share the extraordinary story of the Victorian Goldfields with people from across the globe.

Create social, cultural and economic opportunities for every community and person across the region.

Timeframe (to date)

- Late 2022 State Government commits 'in principle' to submitting an application to the Australian Government for Tentative Listing
- State Government through RDV provides \$500,000 to match \$125,000 raised regionally, to fund a series of specialist consultancies Sustainable Tourism Master Plan and Identification of Potential Sites for 'Tentative Listing'
- May 2023 Minister for Planning states that she will 'expedite' the project to submit a Tentative List application to the Commonwealth in 2024 (for their review)
- 2023 May State Budget allocates \$3.8m to Heritage Victoria for two WH bids including the Victorian Goldfields and sets up a timetable for full nomination to UNESCO by 2026 (indicative only)

The Process for World Heritage Nomination in Australia



Stage 2: World Heritage Tentative List



The **Australian Government** must **add** the Victorian Goldfields to their **Tentative List** at least **one year prior** to **nominating** the Goldfields for World Heritage Listing

From nomination to World Heritage Inscription takes 18 months

Stage 3: Nomination for World Heritage

Stage 4: Assessment

Stage 5: World Heritage List

VICTORIAN GOLDFIELDS: Bid Process July 2022 –November 2023

Shift to 'Victorian Goldfields' - 2023 to bring in additional local Government Areas to strengthen the bid

International and national comparisons (on-the-ground) – 2023 - Barry Gamble, World Heritage Expert, UK

VICTORIAN GOLDFIELDS: Bid Process July 2022 -November 2023

Comparative analysis, December 2020 to November 2023

- To ensure OUV of Victorian Goldfields is justified through robust comparative analysis at the global, national, and local level.
- To demonstrate that the Victorian Goldfields is both exceptional and there is a place for it on the World Heritage List.

Site investigations, December 2022 - Ongoing – Barry Gamble, World Heritage Expert, UK & local experts

Appointment of Australian consultants: December 2022 – December 2023





CORNWALL - WEST DEVONWorld Heritage Site Model

Ten unique areas: One World Heritage Site

This Cultural Landscape Serial Listing model:

- Inscribes a series of areas to better demonstrate the full Outstanding Universal Value narrative
- Spreads the benefits of World Heritage Listing across the region



Cornwall West Devon Mining Landscape

APPLYING THE CORNWALL - WEST DEVON MODEL TO THE VICTORIAN GOLDFIELDS

Need to ensure a balanced selection of sites.

Attributes need to be appropriately represented and distributed across the landscape.

Identify the 'signature sites' a series of places from the alluvial diggings to the deep leads and super quartz reefs.

Best and most coherent but representative of the whole

"...Capture in the landscape sufficiently in a series of sites from gold rush to end of 19th century to form a 'compositional integrity' that illustrates the breadth and essential components, and a single OUV of one of the world's sensational gold rushes..."









VICTORIAN GOLDFIELDS: Attribute groups and attributes

Alluvial mining

• Water races, shallow shafts, puddlersetc.

Quartz Reef and Deep Lead Mining

Open cuts, adits, deep shafts etc.

Ore Processing

Batteries, roasting kilns, cyanide vats etc.

Social Infrastructure

• Burial grounds, recreation grounds etc.

Goldfield Architecture (archetype)

• Banks, Post Offices, Town Halls, Courthouses etc.

Goldfield Architecture (housing)

Cottage, homestead, mansion etc.

Goldfield Architecture (religion/ethnicity)

• Market gardens, timber etc.





VICTORIAN GOLDFIELDS: LANDSCAPE CHARACTER AREAS








WHAT MAKES THE VICTORIAN GOLDFIELDS STAND OUT?

Extraordinary preservation of alluvial mining provides eloquent testimony to the gold rush era.



Victorian Goldfields illustrates the entire technological and architectural goldrush ensemble in the landscape.

Predominant absence of goldmining activity between 1915 and the early 1980s exploration and timely heritage conservation.

Crown Land prohibiting successive large-scale corporate hydraulic mining and dredging.




Social infrastructure that was sustained by permanent settlement and which maintains a viable future.



VICTORIAN GOLDFIELDS WORLD HERITAGE - A CATALYST FOR REGIONAL REGENERATION

The Victorian Goldfields has uneven social and economic opportunities, visitation and a lack of services for locals and visitors.

However, it has extensive, and what we now know as, globally significant heritage assets.



Cultural heritage is vital to the wellbeing of communities.

It provides opportunities for connection to place and each other.



Celebrating and sharing our story with the world will leverage and strengthen this community pride.

Bring people together.

Build local community capacity.

Create new confidence in the future.



World Heritage listing of globally significant sites will shine light on the extraordinary story of the Victorian Goldfields.



PEOPLE ARE EXCITED ABOUT THE POSSIBILITIES BUT UNLOCKING THE BENEFITS WILL TAKE ALL OF US WORKING TOGETHER.



- 2.2 MilliON new visitors over 10 years
- From 9.4 MilliON visitors 2019 (base year)
 to 11.6 MilliON visitors (year 10)
- INCREASE in visitor spending average of \$44 MILLION each year (\$440 million over 10 years)
- 1750 new local tourism jobs over 10 years
- Increase in rooms over 10 years = 4140
- Investment in new visitor accommodation = \$570 MILLION over 10 years

World Heritage listing is estimated to be worth \$1 billion to the region over 10 years.

And it provides opportunities to:

Increase tourism to unlock new opportunities that will drive regional regeneration and sustainable growth.

Create new investment and new jobs.

Celebrate and elevate Aboriginal Cultural Heritage.

Master Plan: Key moves

- Develop a series of World Heritage Journeys
- Support access to and amenity of heritage sites and townships
- Create World Heritage signature experiences
- Get World Heritage Ready (including sustainable tourism accreditation)
- Promote and raise awareness of the Victorian Goldfields and its communities


Targeted Investment

to address the following challenges:

- Globally significant heritage assets under-utilised, unrecognised and under-resourced
- Pronounced socio-economic disadvantage across the region embedded vulnerability
- Untargeted investment private sector hasn't had the level of certainty needed to invest

 Prevalence of poor-quality visitor experiences/services, unevenness in visitation and capacity/attractions

A sustainable tourism masterplan featuring World Heritage Journeys to disperse visitors, and visitor dollars, throughout the Goldfields.



What's next? - after Tentative Listing

- Developing the nomination dossier and management plan –2 years
- Wide scale community engagement and participation
- Extensive industry and key stakeholder engagement and participation
- Resourcing and management for the nomination/post nomination and regional regeneration and tourism masterplan delivery

What is the effect of World Heritage Listing?

- Ultimately the World Heritage Committee will decide whether the Victorian Goldfields will be listed.
- Other than the power to delist sites, because they no longer contribute to the statement of Outstanding Universal Value, UNESCO has no role in site management, the determination of planning permit applications, or tourism development for listed World Heritage sites.
